**APPLICATION FOR OFF PREMISES ALCOHOLIC BEVERAGES DELIVERY
(Class B Only Drinks-To-Go)**

Legislation signed by the Governor, which took effect July 1, 2021, continues to allow alcoholic beverages to go with a prepared meal and includes a two-year sunset provision. For now, sales for off premise consumption with a prepared meal by restaurants, bars and taverns by delivery, curbside or carry out will expire June 30, 2023.

Licensee(s) may only deliver alcoholic beverages off the licensed premises if the licensee has been awarded a valid Letter of Authorization from the Board of License Commissioners. Deliveries may not be made after 12:00 a.m.

The following rules applies to drinks-to-go:

Meal(s) must be ordered. Alcoholic beverages with a prepared meal can only be sold to individuals who are at least 21 years of age or older.

There is a two (2) drink maximum per meal. Drinks to go must be in a sealed, tamper proof container, including bottles, cans, growlers, crowlers and takeout cups with lids for off-premises consumption.

Delivery must be made by employees of the licensed establishment. State law prohibits the delivery of alcohol by a third party, such as Grubhub or Uber Eats.

Deliveries may not be made to any other alcoholic beverage license premise or any property where alcohol is prohibited.

Types of Alcohol Eligible for Delivery:

Beer - no larger than 16 fluid ounces.

Wine - no larger than 8 fluid ounces.

Mixed drinks or cocktail - no larger than 2 ounces of liquor.
