In the matter of **t/a Delicias La Chocita**, the Board reviewed an alleged violation of sale to a minor. Mr. Camacho moved to show cause, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Graham.

In the matter of **t/a Bill's Wine and Liquor**, the Board reviewed an alleged violation of sale to a minor. Mr. Camacho moved to show cause, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Graham.

In the matter of **t/a C.D. Liquors**, the Board reviewed a letter and operating agreement dated June 18, 2018. Mr. Camacho moved to approve the operating agreement, seconded by Mr. Bowman and made unanimous by Mr. Miles and Mr. Graham.

In the matter of **t/a Crescent Beer and Wine**, the Board reviewed documentation provided per their request at the July 24, 2018 hearing pertaining to the transfer of a Special Sunday Sales Permit with a liquor license transfer. Mr. Camacho moved that a Special Sunday Sales Permit would not transfer along with the transfer of a license as described in the Board's Rules and Regulations, seconded by Mr. Miles and made unanimous by Mr. Miles and Mr. Graham.

In the matter of **t/a Hilltop Wine & Spirits**, see letter dated July 31, 2018 requesting clarification on Special Sunday Sales Permit and the transfer of location that was approved July 24, 2018. Mr. Camacho moved that a Special Sunday Sales Permit would not transfer along with the transfer of a license as described in the Board's Rules and Regulations, seconded by Mr. Miles and made unanimous by Mr. Miles and Mr. Graham.

In the matter of **t/a Calvert Brewing Company**, the Board reviewed an e-mail dated July 27, 2018 regarding a proposed diagram for their previous request for outside space. Mr. Camacho moved to approve the diagram and the event, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Graham.

In the matter of **t/a Cadillac Ranch All American Bar & Grill**, the Board took notice of a letter dated July 27, 2018 regarding the cessation of live entertainment until further notice.

In the matter of **t/a #1 Liquors**, the Board received notice of a second application to transfer the license. Mr. Camacho moved to withdraw the pending transfer as a second application for transfer of the license had been filed, seconded by Mr. Bowman and made unanimous by Mr. Miles and Mr. Graham.
