The annual collection/hauler vehicle inspections begin on August 21, 2023 at the Brown Station Road Sanitary Landfill. Health Department Inspections will be performed Monday through Friday, August 21<sup>st</sup> through August 25<sup>th</sup>, between 9:00 a.m. – 12:00 p.m. and 1:00 p.m. - 3:00 p.m. Make-up days after the renewal period are August 31<sup>st</sup>, September 7<sup>th</sup>, September 14<sup>th</sup>, and September 21, 2023. Permits/licenses will be issued beginning September 5, 2023. Health Department Vehicle License Inspection must accompany permit applications/renewals. After, inspection please assemble and email your vehicle registration(s), vehicle license inspection(s) for each vehicle you wish to permit and the Collectors License application to [vehiclepermits@co.pg.md.us](mailto:vehiclepermits@co.pg.md.us). We will notify you of your costs and schedule an appointment for payment and pick up.

**The owner of any licensed vehicle, which is NOT inspected by September 30, 2023, shall be subject to a late fee of \$500.00 per vehicle/permit.** The only exception is for those trucks that failed the initial inspection during one of the on-time inspection dates, if the reinspection was performed within 20 business days of the failed inspection date. It is highly advisable to take your trucks for Health Department inspection during one of the early inspection dates and avoid waiting to the last date(s) to take your trucks in for inspection.

*NOTE: Collection trucks not bearing the new permit sticker will not be allowed access to the Prince George's County facilities and maybe subject to County motor vehicle violations if operating on County roadways without the proper permit renewal. Again, it is highly recommendable to get your trucks in early for inspection and not wait until the last available inspection dates.*
