In the matter of **t/a IHOP**, the Board reviewed an alleged sale to minor violation. Mr. Camacho moved to an offer and compromise with a fine of \$1,500 and to take an Alcohol Awareness Training within 90 days, and made unanimous by Ms. Norman, Ms. Sparkman, Mr. Smith, and Ms. Bridgwaters-Simms.

In the matter of **t/a Taqueria Habanero**, the Board reviewed an alleged Other than a Wholesaler and Failure to Keep Records violations. The Commissioners voted by unanimous consent to show cause the establishment.

In the matter **t/a Area Code**, submitted a request on October 31, 2023, to change the trade name back to Mustang's. This matter was heard on the November 14, 2023, Administrative Voting Session Agenda, however, a proper vote approves conducted. Mr. Camacho moved to allow the trade name change back to Mustang's, and made unanimous by Ms. Norman, Ms. Sparkman, Mr. Smith, and Ms. Bridgwaters-Simms.
