FOODS SERVED	<p>If the food served is coming to the market prepared, proof must be provided that the food is from an approved source. If you, the applicant, are preparing the food served off-site, you must provide a copy of your food service facility permit where the foods are prepared. If you are transporting foods to the market to be served, you must be able to show how the foods will be kept within temperature in compliance with COMAR 10.15.03 during transportation. Unless there is approved on-site equipment to properly reheat food, all foods must be served in the state in which they arrive at the site. Failure to provide both: 1) proof that all prepared food is from an approved source, or 2) proof that proper food temperature is maintained, will result in the food being detained, or food ordered destroyed, and the suspension of your Permit to Operate a Food Service Facility.</p>
