PROOF OF LEGAL STATUS

Pursuant to Section 10-103 of Article 2B of the Annotated Code of Maryland applicants for an alcoholic beverage license shall provide proof of the applicant's legal status at the time of filing the application. In order to meet the requirement the Board will accept:

1. United States Passport or United States Passport Card **or**
2. Naturalization Certificate **or**
3. Permanent Resident Card (Green Card)

Or One Document from Column A and One from Column B

Column A

- Driver's License
- ID Card issued by federal, state or local government
- US Military Card
- Military dependent's ID Card

Column B

- Social Security Card
- Certificate of Birth Abroad
- Certificate of Birth issued by the Department of State
- Original or certified copy of birth certificate
- US Citizen ID Card
- Identification Card for Use of Resident

RESIDENCY REQUIREMENTS:

(a) **Sole Owners** – All sole owners or sole proprietors must have resided in Prince George's County for two years prior to the application for a license and must be registered to vote in Prince George's County. Residence and voting status must be maintained while the individual(s) remains on the license.

(b) **Corporations/Limited Liability Company** – One of the officers of a Corporation/LLC applying for the use of a license must qualify as above. In addition to the residence and voting requirements, the Prince George's County officer/member who is to act as the Resident Agent for the license must also hold 25% of the outstanding stock of the Corporation/LLC. However, if the corporation/LLC is one whose sale of stock is authorized by the Securities and Exchange Commission, the residency requirement does not apply.

In the case of a *Corporation* where there are less than three officers or directors of the corporation, all officers or directors, as the case may be, shall make the application for the license. In the event there are no officers/members or directors of the corporation, at least one stockholder may make the application, if there is an affirmative vote of the stockholders holding a majority of the stock.

CRIMINAL BACKGROUND INVESTIGATION CHECKS:

The Board of License Commissioner's Office must receive the results of the completed Criminal Background Investigation checks prior to the scheduled hearing date. The forms may be obtained from the Board of License Commissioners office and are to be filed directly with the Central Repository with the appropriate fee.

INTERIOR DESIGN LAYOUT:

Applications for new licenses, transfer of licenses, and transfer of location of licenses must be accompanied, at the time of filing, an Interior Design Layout of the establishment. The interior design layout is to be a file size copy, 8.5 x 11. Specific details must be provided as to the square footage for on and off sale areas.

PROHIBITIONS:

No license shall be granted to sell alcoholic beverages within 1,000 feet of a school building or 500 feet of a church.

The Board of License Commissioners has a limited number of licenses to issue; therefore, an application for an alcoholic beverage license may not be considered prima facie evidence that the applicant(s) is/are entitled to a license. (Section 9-217) The Commissioners may not grant any additional licenses of any class that were not determined and posted as available for hearing (Section 10-202).

- Final Inspection for New or Transfer of Location – provide five day notice in writing prior to issuance for Inspection Staff to perform the inspection
- HOTELS AND BLX LICENSE, applicants are required to provide CPA Affidavits, Invoices and Cancelled Checks for their respective Capital Investment as required by Sections 6-201 of Article 2B of the Annotated Code of Maryland.
