**CHARGES:**

Allegedly Isaac Alvarez-Santizo's dog, a black and white, female American Bulldog mix named 'Taylor', was running at large on June 23, 2020 and without provocation attacked a Mrs. Jennifer Anderson's dog, who was being walked on leash by her son. Mrs. Anderson's dog, 'Diamond', suffered multiple injuries, including large, deep lacerations to her left hindquarter. At the time of the attack 'Taylor' was current on County License and rabies vaccination. Your dog shows the propensity to be dangerous by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Dangerous Animals', and Section 3-142 'Irresponsible Pet Owner' of the Prince George's County Code.

Allegedly Brian Vasquez-Rivas's dog, a brown and white, American Staffordshire Terrier mix named 'Blu', on December 28, 2020 jumped the fence at 11401 Caroline Avenue and attacked Ms. Nirmal's dog, 'Balto' a black and white husky, while being walked on leash in front of the address. Prince George's County Police assisted in the impoundment due to the resident, who was not the owner, being uncooperative. This attack resulted in injuries to the victim dog's neck. Your dog shows the propensity to be dangerous by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Dangerous Animals', Section 3-142 'Irresponsible Pet Owner', and Section 3-185.01 'Pit Bull Terriers' of the Prince George's County Code.
