In the matter of **t/a Old Town Inn**, the Board reviewed a letter dated July 31, 2019 regarding a request for a reduction in fines assessed at the July 7, 2019 hearing and additional time to pay. Mr. Camacho moved to approve the request for a payment plan of 90-days to pay the fines with the first payment due immediately and deny the request for a reduction in the amount of the fines assessed, seconded by Ms. Norman and made unanimous by Ms. Sparkman and Ms. Turpin Forbes.

In the matter of **t/a Riviera Tapas Bar**, the Board reviewed a letter dated July 24, 2019 regarding a request for the alcoholic beverage license to extend to the patio area. Mr. Camacho moved to approve the request,
