Complaint Process

Dear Citizen,

It is the policy of the Prince George's County Office of the Sheriff to investigate all complaints against our agency employees. All complaints will be handled confidentially and are assigned to an investigator in the Office of Internal Affairs/Policy Compliance or a supervisor within our agency. Citizens may file a complaint in person, by mail, or telephone.

Ways to file a complaint:

- Call the Sheriff's Office and ask to speak to the supervisor of the deputy or an on-duty supervisor, 301-780-8600. (24 hours)
- Call the Internal Affairs Office at 301-213-5984 (M F, 9:00 a.m. 5:00 p.m.)
- Complete the complaint form. Completed complaint forms may be submitted in person during business hours (M F, 8:00 a.m. 4:30 p.m.) to an Office of the Sheriff supervisor at our Sheriff Headquarters, mailed to the below address or emailed to sheriffIAD@co.pg.md.us. (complaint forms are available at our Headquarters)
