**NOTICE OF FUNDING AVAILABILITY (NoFA)  
AND  
PROGRAM YEAR (PY) 46 APPLICATION AND PROPOSAL WORKSHOP**

The Department of Housing and Community Development of Prince George's County, Maryland will be accepting Community Development Block Grant (CDBG) applications for **Program Year 46, covering July 1, 2020 to June 30, 2021**. Applications will be available online on **Wednesday, September 25, 2019**. The application submission deadline is **Friday, October 25, 2019 at 5:00 p.m.**

CDBG funds are used to promote viable communities by providing decent housing, suitable living environments and expanding economic opportunities primarily to low and moderate-income persons. Applications will be accepted, and consideration will be given to shovel ready projects. Additionally, Applicants with outstanding prior years funding, including Program Year 45 and prior, may not be eligible for funding.
