The Prince George's County Department of Public Works and Transportation (DPW&T) will begin construction of the Montpelier Drive Street Improvements (Contract 905- H (E)), from MD-197 to south of Carland Place in June 2020.

This meeting will provide attendees the opportunity to understand the project's scope, proposed tree removal schedule, upcoming construction schedule, ask questions, and provide comments regarding construction. 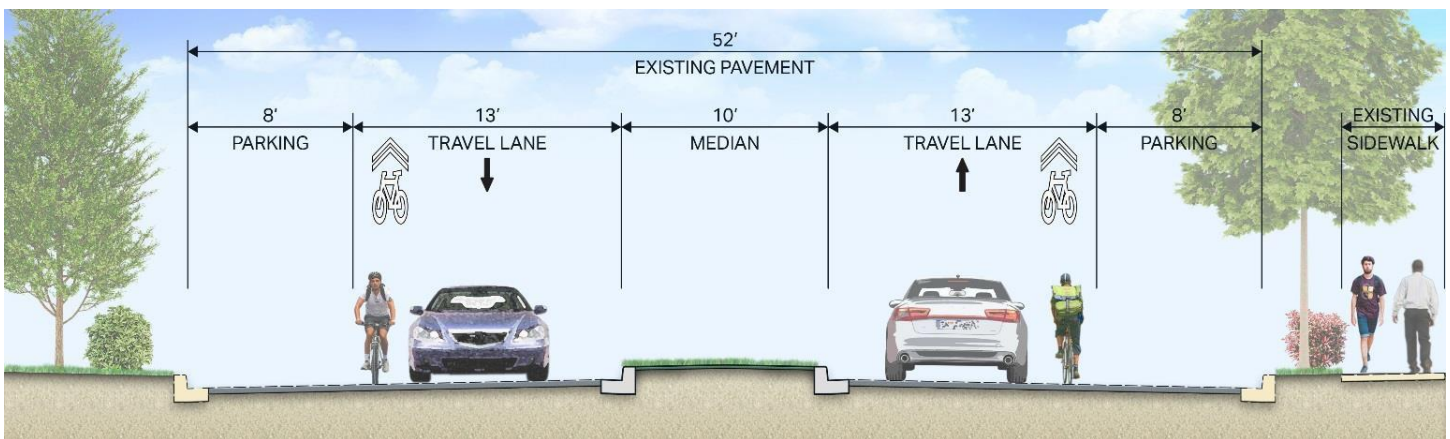

## PROJECT IMPROVEMENTS & OBJECTIVES

The primary objective of the Montpelier Drive Street Improvements Project is traffic calming/speed reduction. Project improvements will include raised medians for traffic calming, curb extensions to create a reduced crossing distance for pedestrians, and new pavement markings to designate travel, bicycle, and parking lanes. Other improvements will include a complete repaving of the roadway, replacement of deteriorated sidewalks and driveway aprons, new high-visibility signage, and the installation of drainage inlets and underdrains, where needed. The project will also include removal and replacement of high-risk Bradford Pear trees along Montpelier Drive with sturdier trees.

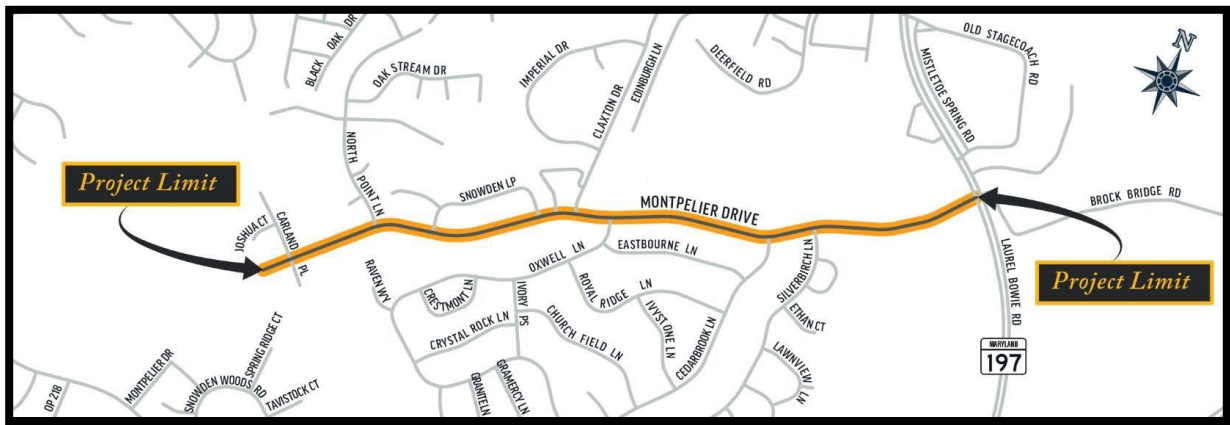


Typical Section with 10' Median
