### STATE ROADS

Roads identified by a **NUMBER** (EX. MARYLAND 210, 5) are **STATE ROADS**.

Plowing of snow on those roads is conducted by the Maryland State Highway Administration. Phone: 301-513-7305.



### *THE BUS*

During snow events, service levels are **FULL, MODIFIED, LIMITED, OR NO SERVICE**.

**FULL SERVICE:** All routes operating, but delays possible. Specific stops within routes may be impacted.

**MODIFIED SERVICE:** Most routes running with reduced frequency. Routes in residential areas prone to icing may be cancelled.

**LIMITED SERVICE:** Service significantly reduced, primarily serving major corridors.

**NO SERVICE:** *TheBus* is not operating.

## SNOW AND ICE CONTROL OPERATIONS



When a snow emergency is declared, the Prince George's County Department of Public Works and Transportation (DPW&T) is responsible for providing "passable" conditions over a network of more than 1,900 miles of County maintained roadways. Treating roadways consists of plowing and/or salting, as warranted by weather conditions.

### WHAT TO EXPECT DURING A SNOW EMERGENCY EVENT

- \* PARKING IS PROHIBITED ALONG ALL DESIGNATED SNOW EMERGENCY ROUTES.
- \* RESIDENTS SHOULD PARK IN DRIVEWAYS.
- \* IF ON-STREET PARKING IS NECESSARY, PARKING IS PERMITTED ONLY ON THE EVEN-NUMBERED SIDE OF THE STREET. ABANDONED VEHICLES WILL BE TOWED.
- \* ONCE THE ROAD HAS BEEN TREATED AND PLOWED, CARS MUST BE MOVED TO THE ODD-NUMBERED SIDE OF THE STREET.
- \* FAILURE TO COMPLY COULD RESULT IN FINES AND/OR TOWING.
- \* PRIMARY AND COLLECTOR ROADS WILL BE PLOWED AND TREATED DURING ACTIVE SNOWFALL. ONCE THE SNOW STOPS, RESOURCES WILL MOVE INTO RESIDENTIAL AREAS.
- \* TO AVOID SHOVELING THE DRIVEWAY MULTIPLE TIMES, PLEASE SHOVEL AFTER THE STREET HAS BEEN PLOWED.
- \* FOR SNOW REMOVAL REQUESTS, CALL 311 **24 HOURS AFTER THE SNOW HAS ENDED.**

## ROAD PLOWED TERMS



### SNOW OPERATIONS DEPLOY BASED ON WEATHER CONDITIONS

- **Level 1** - Snowflake/Modified - 0-2 inches of snow
- **Level 2** - Full Operation with Limited Contractor Support - 3-6 inches of snow
- **Level 3** - Full Operation with Full Contractor Support - 6-12 inches of snow
- **Level 4** - Full Operation with Full Contractor Support and Heavy Equipment - 12+ inches of snow/blizzard

## WORKING TOGETHER: HOW YOU CAN PLAN FOR SNOW

- \* PARK ON THE EVEN-NUMBERED SIDE OF RESIDENTIAL STREETS OR IN DRIVEWAYS.
- \* CONTACT THE APPROPRIATE HEALTH PROVIDER FOR DIALYSIS TREATMENTS.
- \* PICK UP ANY REQUIRED MEDICATIONS.
- \* HAVE A SUPPLY OF ROCK SALT, CAT LITTER OR SAND AVAILABLE.
- \* HAVE YOUR HEATING FUEL LEVEL CHECKED AND FILLED, IF NEEDED.
- \* HAVE FLASHLIGHTS, EXTRA BATTERIES, BATTERY OPERATED RADIO AND FRESH BOTTLED WATER ON HAND.
- \* KEEP A STOCK OF PACKAGED FOODS THAT DON'T NEED REFRIGERATION AND MAY BE PREPARED WITHOUT ELECTRICAL POWER.
- \* PLEASE CHECK ON VULNERABLE RESIDENTS AND SENIOR CITIZENS IN YOUR COMMUNITY AS WINTER CONDITIONS CAN CAUSE A WIDE RANGE OF INJURIES AND ILLNESSES.
- \* TRASH, RECYCLING AND YARD WASTE PICKUP MAY BE IMPACTED DURING SNOW EVENTS.
