This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-132 'Public Nuisance', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', Section 3-185.01 'Pit Bull Terriers', and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

CHARGE:

This is in violation of Section 3-180 'Cruelty and Neglect', Section 3-131 'Manner of Keeping Animals', Section 3-185.01 'Pit Bull Terriers', Section 3-145 'Ferret, Dog, and Cat Licenses' and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

No. 18-16 JEAN MORENCY

v.

PRINCE GEORGE'S COUNTY, MD

PETITION:

For return of custody of a male, black and white, Pit Bull that was impounded by the Animal Management Division on February 24, 2016 to protect its safety and welfare. Allegedly, Jean Morency was found in violation of Section 3-185.01 'Pit Bull Terriers' of the Prince George's County Code.

GENERAL RULES

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
