For return of custody of a 6-month old, male, tri-color, Pit Bull named 'Heavy', 6-month old, female, tri-color, Pit Bull named 'Majesty', 6-month old, male, tri-color, Pit Bull named 'Pyro', and a 1-year old, female, tri-color, Pit Bull named 'Lionus' that were impounded by the Animal Management Division on October 4, 2016. Allegedly, Andrea Drain and Christopher Williams were found in violation of Section 3-185.01 'Pit Bull Terriers' of the Prince George's County Code.

CHARGE:

Allegedly Raul Tucsta is creating a public nuisance by threating to have his dog attack Vanessa Fleeton. Additionally, Raul Tucsta came before the Animal Commission on May 14, 2014 and was ordered to pay fines in the amount of seventy-five (\$75.00) dollars. Tucsta was ordered to keep his dog named 'Tiger' indoors at all times and only allowed outside on a leash and under adult supervision. This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', Section 3-145 'Ferret, Dog, and Cat Licenses' and Section 3-186 'Vaccination of Ferrets, Dogs and Cats' of the Prince George's County Code.

v. MICHAEL SMITH, SR.

CHARGE:

Allegedly on September 24, 2016, Michael Smith's male, fray with white, Japanese Akita mix named 'Makucee' was running at large and without provocation attacked and severely injured Carolyn Boyd's dog named 'Trixie'. Your Japanese Akita mix shows the propensity to be vicious by virtue of the alleged attack. This is in violation of Section 3-131 'Manner of Keeping Animals' and Section 3-135 'Animals at Large Prohibited' and Section 3-136 'Vicious Animals' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
