This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', Section 3-145 'Ferret,

Dog and Cat Licenses' and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

CHARGE:

Allegedly, on January 26, 2017, Nicole Midkiff 's male, brindle, Labrador mix named 'Buddy' was running at large and bit 4-year old Tristan Pointer on the face while he was at the bus stop. Your dog shows the propensity to be vicious by virtue of running at large and biting Tristan Pointer on the face. This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', and Section 3-145 'Ferret, Dog, and Cat Licenses' of the Prince George's County Code.

v. SAUL HERRERA

CHARGE:

Allegedly, on February 3, 2017, Saul Herrera's two, male, black and tan, Yorkshire Terrier mix(s) named 'Bary Black' and 'Sparky bit without provocation Michelle Hanks. In 2015, Marsha Banks was bitten on the leg. Ms. Banks is now deceased. On February 1, 2017, Jasmine Hanks was bitten by the dogs. Your dogs show the propensity to be vicious by virtue of the alleged attacks and bites. This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-135 'Animals at Large Prohibited', Section 3-136 'Vicious Animals', Section 3-145 'Ferret, Dog, and Cat Licenses' and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
