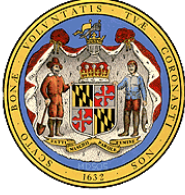

1. Certified check, cashier's check or money order payable to Prince George's County for the appropriate fee
 - a. Special Entertainment Permit \$1,500
 - b. Family Entertainment Permit \$250
2. Letter from the Prince George's County Police Department indicating that the business' Security Plan is current.
 - a. This letter can be obtained by contacting the Prince George's County Police by email at PGPD_SP@co.pg.md.us
3. A copy of the Use and Occupancy Permit that reflects entertainment is permitted.

Note: If the licensee wants to amend the entertainment described in this form, the changes must first be submitted to the Board for approval prior to the implementation of such changes with evidence of approval by the Prince George's County Police Department.
