COUNTY ATTACKS ROADSIDE LITTER WITH SIGN BLITZ

Each year, the County conducts Sign Blitz events that are usually held in the spring and fall.

DPIE works with DoE, DPW&T, the State Highway Administration (SHA) and local municipalities to remove thousands of illegal signs from local rights-of-way. The signs create an eyesore and pose a safety hazard by distracting drivers' attention.

To date in 2021, the County has held three litter blitzes and have removed more than 5,000 illegal signs along our roadways.







DPIE's BEAUTIFY AND COMPLY!

DPIE has implemented a new program to encourage residents to make repairs to their properties to bring them into compliance with County code while planting flowers and making other preparations for summer — "Beautify and Comply!"

Under the program, residents are asked to review a list of common property maintenance issues and repair any that exist on their property.

- Spruce up and secure vacant property.

DPIE's NO LITTER LANDSCAPE

The Zoning Unit of the DPIE Enforcement Division works with businesses to address property maintenance problems, including allowing trash and debris to accumulate.

Property owners and managers are responsible for keeping their properties clear of unsightly litter. Trash receptacles should be sufficient to prevent spillover that creates litter.

The areas around them should be picked up regularly to keep them clear of trash. Failing to maintain a trash-free property is a violation of County code punishable by a fine of up to \$1,000 per violation.







CLEAN OR LIEN IT

Have you heard about DPIE's "Clean It and Lien It" program?

Littered lots are cleaned by hired contractors and DPIE places liens to recoup the costs.

The program helps clean up lots that are hurting property value and frustrating residents.

The Department of the Environment (DoE) designed PGCLitterTRAK to assist County residents, community organizations and businesses in reporting trash and debris collected during individual and group cleanup events.

Information submitted through PGCLitterTRAK including bags of litter removed, items collected and litter pick-up locations will assist DoE meet their trash reduction rate of 170,628 pounds per year within the Anacostia River Watershed.

Data provided will also help DoE develop real-time maps cataloging litter collected throughout the County.




DPW&T's ADOPT-A-ROAD/MEDIAN PROGRAM

ALWAYS REPORT ILLEGAL DUMPING TO PGC311

Did you know that illegal dumping can have an adverse affect on human health?

Dumping sites attract insects and animals that have illnesses that can be detrimental to humans. When you report incidences of trash or illegal dumping to PGC311, the following agencies investigate the matter:

DPIE addresses trash on residential or commercial lots and private property.

DoE collects trash, recycling, bulky trash and yard trim.

DPW&T addresses complaints about trash or illegal dumping on sidewalks, roads, public rights-of-way, etc.
