

**HOUSING AUTHORITY OF PRINCE GEORGE'S COUNTY**  
**PRELIMINARY APPLICATION PROCESS FOR**  
**AMENDMENTS TO THE HOUSING CHOICE VOUCHER (HCV) ADMINISTRATIVE PLAN/  
OPENING THE HCV (Section 8) WAIT LIST**

The Housing Authority of Prince George's County (HAPGC) is proposing to amend chapter 4 of the Housing Choice Voucher administrative plan entitled **Applications, Waiting list and Tenant Selection**; to provide for the acceptance of online applications only. The HAPGC is also proposing to re-open the Housing Choice Voucher (HCV) program wait list to new applicants at a later date in 2015. In order to accept new applications the Housing Authority has been continually updating and purging the existing list since 2008. The HAPGC closed our wait list in 2008 and has contacted all of the applicants that applied during the 2008 waitlist opening.

The HAPGC public comment period will begin on **July 23, 2015** and the HAPGC will continue to receive written comments until **August 23, 2015** at 5:00pm. The Public Hearing will be held on **August 3, 2015** beginning at 5:00pm and ending at 6:30pm, the location of the hearing is 1801 McCormick Dr. Largo, Maryland 20774 conference room 104.

HCVP is a federally funded, locally administered rental assistance program that helps low-income families with children, the elderly, and individuals with disabilities afford decent, safe housing in the private market. The voucher allows a household who receives it to rent a privately owned apartment or house of their choice if it meets all HCVP requirements.
