In the matter of **t/a Hampton Liquor Store**, purchasing from other than a wholesaler – licensee provided the Board with a receipt for the product on May 17, 2018. The Chairman indicated that this items would not be show caused.

In the matter of **t/a House of Lee**, the Board was advised of an alleged violation of purchasing from other than a wholesaler. Mr. Camacho moved to issue a show cause, seconded by Mr. Miles and made unanimous by Mr. Bowman and Mr. Graham.

In the matter of **t/a Lee's Restaurant**, the Board was advised the owner of the real property came to the office and indicated that the business does not have a lease and that the renewal application filed is improper – licensee provided a lease with a lease extension. So Noted.
