sales; that they have had one violation on their license in the entire time they have been license holders; that the violation was an underage sale.

Karen Murray agreed to the information and statements provided by Mr. Murray.

<u>Rosa Bustamante</u> stated that she is a resident of Beltsville; that she will be at the establishment approximately 5-6 hours a week; that she has full time employment elsewhere.

Mr. Camacho moved to approve the transfer application, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

Steven Cesinger stated he is a resident of Georgia; that he is an employee of Valor; that they hold 10 businesses within the U.S. and 35 globally; that this would be the first business in Maryland;

that they will transition the business from a Marriott, to simply Greenbelt Hotel, to a Crown Plaza; that he is familiar with the rules and regulations; that he is able to abide by them; that he will at the business a few times a year; that he has not been convicted of any felonies; that he has never held a license that has had a violation; that he has never had a license that has been revoked; that he is aware the legal drinking age is 21 and the age to serve is 18; named the five acceptable forms of identification.

Mr. Camacho moved to approve the transfer application, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

Emma Lim-Bioc stated that she is a resident of Silver Springs; that she has been a resident for 31 years; they have had a previous location but not one with a liquor license; that they have had the restaurant in Beltsville for 13 years; that it is was just carry out; that it will be a sit down full service restaurant; that they would also like to add on the sale of beer and wine; that she has not been convicted of a felony; that she has no interest in any other business with a liquor license; that she has never been found in violation; that she has a 25% interest in the business; that she will be at the business 40 hours a week; that she has her Alcohol Awareness Certificate; that they are involved with the community in projects, fundraisers, and other events; that the legal age to serve alcohol is 18 and the legal age to consume is 21; named the five acceptable forms of identification.

<u>Toni Lim-Bioc</u> stated that she is a resident of Silver Springs; that she has been a resident for 24 years; that she has not had a felony conviction; that she holds no other license; that she has no interest in another business that sells alcohol; that she has never had a violation; that she has a 50% interest in the business; that the menu will be Filipino food; that she will be at the restaurant 40 hours a week; that she is aware the legal age to serve is 18 and the legal age to consume is 21; named the five acceptable forms of identification; that they plan to begin renovations in August once all catering contracts have been completed; that they will be closed approximately one month.

Mr. Camacho moved to approve the application, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

Maria Martinez stated that she is a resident of Hyattsville; that she has been a resident for 28 years; that she has not had a license previously; that she does not have an interest in any other businesses; that she has had no violations; that she has not been convicted of any felonies; that food will be 100% authentic Mexican food; that she will work 60 hours per week; that she understands the rules and regulations; that she agrees to abide by them; that they will be able to accommodate the public; that it will not harm the public; that it will benefit the public; that the hours will be from 9:00 a.m. to midnight Monday through Saturday; that the legal drinking age is

21 and the legal age to serve is 18; named the five acceptable forms of identification; that the business will not be providing off sale.

Mr. Camacho moved to amend the application to reflect that they will not be providing off sale and there is no part of the business where such will be permitted, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

Mr. Camacho moved to approve the application, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

In the matter of Adam Greenberg, Member, Suzanne D. Hillman, Member, for a new Class B (BH), Beer, Wine and Liquor for the use of 8321 College Park Hotel ABC, LLC, **t/a Cambria Hotel at College Park**, 8321 Baltimore Avenue, College Park, 20740.

The applicant is represented by Linda Carter, Esquire.

<u>Suzanna Hillman</u> stated that she is a resident of Virginia; that she is aware of the rules and regulations; that she is able to abide by them; that she is a CPA; she named the five acceptable forms of identification; she is aware the legal age to consume alcohol is 21 and the legal age to serve is 18.

Adam Greenberg stated that he is a resident of Potomac Maryland; that he holds licenses in Montgomery County; that he is on the license for Potomac Pizza; named the five acceptable forms of identification; that he is aware the legal age to consume alcohol is 21 and the legal age to serve alcohol is 18; that the restaurant portion of the hotel will be his responsibility; that the food served will be all American; that the restaurant will be a bar and grill; that there will be 12 taps; that there will be live jazz music, pending approval of the Special Entertainment Permit; that the city supports unanimously; that there will be 184 seats in the restaurant and that 46 of those will be bar stools; that there will not be any "drinking games' played at the establishment; that the restaurant will be the sole provider of food for the hotel; that they will provide room service which is set to be pickup only; that the room service for alcohol if they choose to permit is still in progress; that they will either still have to pick up or may deliver to room to ensure occupants drinking age; they will implement the double check process; server checks the identification as well as taking the ID to a manager for them to verify; they will also have ID scanners; that the hours for the restaurant will be 6:00 a.m. to midnight; that room service only available at dinner; that there will be approximately 40 employees; that anyone in contact with alcohol will have Alcohol Awareness Certification; that he is aware of the rules and regulations. Linda Carter, Esquire requested for the application to be amended for an omission made previously.

Adam Greenberg stated he previously omitted three violations on licenses he also held in Montgomery county; that they were on the license at Potomac Pizza; two were at the Potomac location and one at the Chevy Chase location; that they were all due to serving underage. Mr. Camacho moved to amend application for the omission as well as to amend the hours of operation from 7:00 a.m. to midnight to 6:00 a.m. to midnight, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

<u>Robert Ryan</u> stated that he was the director of Public Services from the City of College Park and that the City supports the application.

Mr. Camacho moved to approve the application, seconded by Ms. Kelsey, made unanimous by Mr. Graham.

In the matter of Patrick Davis, Owner, for a new Class B, Beer, Wine, and Liquor for the use of ExclusiveBlu, LLC, **t/a ExclusiveBlu Restaurant and Lounge**, 354 Main Street, Laurel, 20707.

<u>Patrick Davis</u> stated that he has been before the Board previously; that he plans to be open by September; that he has not completed construction; that he still has plumbing and electrical to complete; that his architect told him he should be completed by September; that since he was last here he has gained unanimous approval from the city of Laurel and that they have even updated bylaws to allow him to build; that the building is historical; that he plans to make this establishment a restaurant, lounge and rooftop.

Mr. Camacho questioned the opening date; he stated he did not think it would be possible due to work that would need to be done for a building that old; he believes there is more work involved in renovating the building than was mentioned.

<u>Patrick Davis</u> insisted architect said they will be completed by September; he stated that he has not done work since his last appearance on the actual building; he stated that most of his work has been on gaining further support and approval.

Ms. Kelsey requested more information on his projected timeline.

<u>Patrick Davis</u> stated that plans and drawings have been completed; that the building demo was scheduled for today and that the construction company for the renovations has not yet been contracted.

Mr. Camacho suggested continuing rather than issue the license; he stated the building was previously office space; he stated in his opinion the renovations will take much longer and more extensive; he stated the Board would need actual evidence of the schedule and that none was brought; he stated that they would need witnesses, pictures, etc. for testimony of opening date. Mr. Camacho moved to continue this matter to the August 25th hearing when there has been more work done on the building and a more concrete timeline may be able to be produced, Ms. Kelsey seconded, made unanimous by Mr. Graham.

In the matter of **t/a Jock's Liquors**, licensee requested to appear before the Board to discuss the status of the renovations and pending transfer of the license.

Applicant is represented by Errol Thompson, Esquire.

Thomas Stevenson stated he is a resident of Upper Marlboro; that in 2016 he had come before the Board about the property; that he purchased the property and license in horrible condition; that he needed to obtain the permit to demo the property and rebuild; that the property was built in the 1930's or 1940's; that there was no sewer line previously just a water line; that he had to put in a new sewer and water line; he stated that he had a delay due to WSSC; that he had to make a new plan for lines; that he had to provide DPie with a bond of \$107,000 to cut streets for lines; that his previous construction company had been dismissed for overcharging; that he had to submit an "As Is Permit" to approve the remaining construction because the previous construction company deviated from the approved plans; stated that DPie presented him with comments on remaining work to be completed and problems to fix; he stated that these comments were addressed; that every time he completed a set of requests a new list would be

produced; that he requested all comments be combined for a master list of work needing to be done.

<u>Bill Edelen</u> stated that he is an inspector with DPie; that he is familiar with the case; that DPie uses a third party inspection program; that engineers inspect all aspects; that they monitor paperwork, schedules, work, etc.

Kevin Green stated that he is an inspector/code officer; that he has been with DPie for 19 years and was a fire inspector for 13 years before; that he does quality assurance checks; he stated that Mr. Stevenson had received a permit in October of 2014 to begin demo; that there are quality assurance checks; that they were short staffed in this time period; that in November of 2016 he was able to get back with third party inspectors; he was informed at this meeting that Mr. Stevenson wasn't calling for inspections and that the project was moving slow; he stated that November 18, 2016 was the last date they had received a call for inspections; that they still required inspections for electrical mechanical, parking lot, and that the handicap was not finalized; he projected the project was about 80% completed; he also advised he was serving a notice to Mr. Stevenson today regarding work still needing to be done and if he is unable to comply the matter will be taken to court and the building could possibly be torn down.

Mr. Camacho stated the license was originally transferred in 2014; that Mr. Stevenson was given 2 years to finalize; that this is now 4 years later; that he told Mr. Stevenson when last appeared in January that he needed to produce a U & O in order to continue the matter again; one was not brought in; that he believes the license needs to be retired.

Kevin Green stated that a mechanical, retaining wall, 5 electrical, ceiling close in and a raise permit have been issued.

<u>Thomas Stevenson</u> stated that they have been waiting on an as built permit to close in walls; an "As is Permit" is needed because the contractor deviated from the approved plans and permit; that he's been waiting 6 months for the permit; that he asked the contractor for small deviations. <u>Mr. Graham</u> stated that the delay was self-inflicted.

<u>Thomas Stevenson</u> stated that the deviation was minor; that they still need to submit final permits and requests to have the license continued so that they may submit the plans. Mr. Camacho moved to have the license expired, Ms. Kelsey seconded, and Mr. Graham made it unanimous.
