DRAFT PRINCE GEORGE'S COUNTY FY 2018 ANNUAL ACTION PLAN FOR HOUSING AND COMMUNITY DEVELOPMENT

The Prince George's County Draft FY 2018 Annual Action Plan for Housing and Community Development is now available for public comment for a period of 30 days. The public comment period will end on April 14, 2017. The Annual Action Plan ("AAP") for Housing and Community Development is a comprehensive strategy that describes actions, activities, and programs that will take place during FY 2018 to address priority needs and specific objectives identified in the FY 2016-2020 Consolidated Plan. The AAP also serves as an application for Federal funds: Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG), and HOME Investment Partnerships (HOME).

The FY 2018 formula allocations for the County are: CDBG - \$4,461,422 plus \$204,933 in Program Income; HOME - \$1,548,138 plus \$547,951 in Program Income, and ESG - \$387,732 plus \$387,732 in Matching Funds.
