DRAFT PRINCE GEORGE'S COUNTY FY 2016 ANNUAL ACTION PLAN FOR HOUSING AND COMMUNITY DEVELOPMENT

The Prince George's County Draft FY 2016 Annual Action Plan for Housing and Community Development is now available for public comment for a period of 30 days. The public comment period will end on April 17, 2015. The Annual Action Plan ("AAP") for Housing and Community Development is a comprehensive strategy that describes actions, activities, and programs that will take place during FY 2016 to address priority needs and specific objectives identified in the FY 2016-2020 Consolidated Plan. The AAP also serves as an application for Federal funds: Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), and HOME Investment Partnerships (HOME).

The FY 2016 formula allocations for the County are: CDBG - \$4,307,176 plus \$237,116 in Program Income; HOME - \$1,433,959 plus \$556,735 in Program Income, and ESG - \$389,196, plus \$389,196 in Matching Funds.
