FY 2022 ANNUAL ACTION PLAN FOR  
HOUSING AND COMMUNITY DEVELOPMENT**

The Prince George’s County Draft Fiscal Year (FY) 2022 Annual Action Plan (AAP) for Housing and Community Development is now available for public comment for a period of five (5) days. The public comment period will end on March 22, 2021. The Annual Action Plan for Housing and Community Development is a comprehensive strategy that describes actions, activities, and programs that will take place during FY 2022 to address priority needs and specific objectives identified in the FY 2021-2025 Consolidated Plan. The AAP also serves as an application for the following Federal entitlement funds: Community Development Block Grant (CDBG) Program, HOME Investment Partnerships (HOME) Program, and the Emergency Solutions Grants (ESG) Program.

The FY 2022 AAP is based on the U.S. Department of Housing and Urban Development (HUD)’s Federal FY 2020 (County FY 2021) formula allocations with estimated entitlement allocations for each activity that may be proportionally adjusted to match the actual funding allocations upon notification from HUD. The estimated FY 2022 formula allocations for the County are: CDBG - \$5,506,072 plus \$344,311 in Program Income; HOME - \$2,132,723 plus \$1,072,095 in Program Income; and ESG - \$441,932 plus \$441,932 in Matching Funds.
