### GENERAL NOTES FOR APPLICANTS:

With the exception of rain barrels, a pre-construction meeting is required for all stormwater management techniques.

If the project, on its own or in conjunction with a concurrent project on your property, involves any of the following activities, a permit is likely required.

- 5,000 square feet or more of ground disturbance.
- 100 cubic yards or more of earth moving.
- 12-inch change (+/-) in grade that alters drainage flow.
