- *Proper ID required (i.e. driver's license, State issued ID card, MetroAccess card, Metro senior or disabled card, Medicare card).


Rules & Regulations

SmarTrip cards for payment of fares. Pennies are not accepted. No smoking. No eating or drinking. No pets or animals; service animals are permitted. Electronic devices with earphones only. Buses stop only at designated stops.

General Information

Route 37 provides community bus service in the Southern Avenue, Indian Head Highway, and Camp Springs areas, from 5:29 a.m. to 7:14 p.m. Buses operate Monday through Friday every 17-30 minutes. No service on Saturdays, Sundays, or major holidays (New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, and Christmas Day).
