The Department of Permitting, Inspections and Enforcement (DPIE) is hosting the meeting, which will include updates from our sister agencies, the Department of the Environment (DoE) and DPW&T.

## **DIRECTIONS:**

From the Beltway/SOUTH, take Pennsylvania Avenue (MD4) west to the Forestville Road exit (at Marlo Furniture). Make a right onto Forestville Road and travel through two traffic lights. Please note that Forestville Road turns into Ritchie Road. At the third light, D'Arcy Road, turn right. You will see signs indicating DPW&T Facilities. Continue on D'Arcy Road through the residential section and up the hill. Take the second left turn into the DPW&T Complex. The MOC is the last building on the left. Directional signs to the parking area will be posted.

From the Beltway/NORTH, take the Ritchie-Marlboro Road exit, bear right at the traffic circle and proceed to the first major intersection (Ritchie Marlboro/Walker Mill/Ritchie roads). At the light, turn left onto Ritchie Road. Travel to D'Arcy Road and turn left. You will see signs indicating the DPW&T Facilities. Continue on D'Arcy Road through the residential section and up the hill. Make the second left into the DPW&T Complex. The MOC is the last building on the left. Directional signs to the parking area will be posted.
