Pursuant to Section 2-295(g)(2), each lobbyist shall file with the Board one report covering the period beginning January 1, through December 31, filed by January 31. The report shall include the total expenditures on lobbying activities in each of the following categories:

- \$ Ø (D) Publications which expressly encourage persons to communicate with Prince George's County officials or employees.


