Commissioner Bridgwaters-Simms: At the Board of License Commissioners, we endeavor to be as efficient as possible in our virtual environment. Thank you for your patience. This is a public meeting subject to the Maryland Open Meetings Act so a truthful, transparent, open, and honest dialogue and record is required. As such, there are some formalities that will take place that may appear redundant but nonetheless are important and required to ensure compliance with the law.

Director Sheppard: During a typical hearing, there would be an exchange between the Board and the attorneys to exchange information as exhibits. Because this hearing is now virtual, we have implemented a 10-day rule to give those individuals here today, 10-days from today's date to add to the official record. I would ask that you email myself or the administrative staff of the BOLC. You may add information to the record long as it is information that has been discussed in this hearing.

PRELIMINARY MATTERS:

1. Substitution of Corporate Officers application, **t/a Taqueria Habanero**, Class B, Beer, Wine and Liquor, 8145 Baltimore Avenue, College Park, 20740, Isael Ramirez to serve as Co-Managing Member instead of Carlos Alvarado, Co-Managing Member.
Represented by **Wesley Japp, Esquire**.
Mr. Ramirez is a longtime colleague and friend of Mr. Alvarado, and he wishes to purchase his share of the restaurant.
Mr. Japp asked the standard questions typically used to qualify the Substitution of Corporate Officers Application. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.
Commissioner Sparkman makes a motion to approve the SCO for t/a Taqueria Habanero, seconded by **Commissioner Smith**.

The previous licensee is no longer associated with this license.

The applicant was initially unable to list the six forms of I.D., after pausing this case the applicant was able to answer each question.

Chief Clark gave a maps presentation.
Mr. Patel has been working at Lewisdale Market since March 2023. He grew up in this business.
Mr. Patel is TIPS certified and all cashiers will be TIPS certified.

This liquor license will be a benefit to the community, we submitted a petition to the Board this morning with one hundred and twenty signatures in support of this application. **Mr. Carter** asked the standard questions typically used to qualify the transfer of the license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.

Commissioner Sparkman makes a motion to approve the transfer of location for t/a Lewisdale Market, seconded by **Commissioner Smith**.

Riviera Tapas Bar is a high rated restaurant and very popular for citizens in the area.

Mr. Manocha is currently a licensee at Rocket Liquors in Washington, DC. There have been no violations during his tenure at this location.

Both applicants are Alcohol Awareness certified.

Mr. Carter states Mr. Huang entered a contract to purchase Cox's Liquors and we're hoping to go to settlement in the next couple of months.

Mr. Huang will become TIPS certified if this application is approved. All cashiers will be TIPS certified as well.

There will be no material changes to the operation.

Village Nail Bar II is a full-service nail salon offering manicures, pedicures, waxes, and facials. This establishment opened in September 2022.
Mr. Dung Vo obtained one hundred pages of approximately eight hundred and fifty signatures for a petition of support. Customers have indicated they would like to have this while receiving service.
Mr. Dung Vo is Alcohol Awareness certified; the certificate has been submitted to the Board.
Mr. Kim asked the standard questions used to qualify this type of license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.
Commissioner Sparkman makes a motion to approve the Class D license for t/a Village Nail Bar II, seconded by **Commissioner Smith**.
After Board vote, the motion carries.
2. Charlene Blakenship, CEO, for a Class D, Beer and Wine for the use of Laurel's House of Horror, LLC, **t/a Laurel's House of Horror**, 935 Fairlawn Avenue, Laurel, 20707.
Applicant does not have an attorney, acknowledge her right to an attorney, and agree to move forward without representation.
Chief Clark gave a maps presentation.
Laurel's House of Horror is a haunted house from September through November and during the off season an escape room over the weekend.
In addition, parties are occasionally held at the establishment throughout the year.
Commissioner Camacho asked the standard questions used to qualify this type of license. Including what are the six acceptable forms of I.D., and the legal age to purchase and sell alcohol. The applicant was able to answer each question.
Commissioner Sparkman makes a motion to approve the Class D license for t/a Laurel's House of Horror, seconded by **Commissioner Smith**.

Amigo's Mexican Grill food is inspired by Southern Mexican Cuisine.

The build out isn't fully complete, the anticipated opening date is September 2023.

Mr. Salmoran is Alcohol Awareness certified. Most front-line employees will be Alcohol Awareness certified. Everyone that looks under the age of thirty years old will be carded. No vertical I.D.'s will be accepted, and I.D. scanners will be utilized.
