Commissioner Bridgwaters-Simms: At the Board of License Commissioners, we endeavor to be as efficient as possible in our virtual environment. Thank you for your patience. McCrory, President/Treasurer. Represented by Leanne Schrecengost, Esquire.
 Mr. Rodriguez is the Chief Legal Officer, he leads the legal, risk, licensing, loss prevention and safety teams. He deals with Board relations and compliance as well. Mr.

Mr. Kim asked the standard questions typically used to qualify this kind of license.

Ms. Jackson was able to answer each question. She anticipates having 20 employees.

She has submitted Alcohol Awareness trainings to the Board. She understands the Board's Rules and Regulations and agrees to abide by them. She is currently waiting on DPIE to issue their Use and Occupancy. There will be 100 seats. The square footage is 4500 square feet, restaurant/dining area is 2500 square feet. She will be spending about 40 hours a week on the premises.

Ms. Greene was asked the standard questions typically used to qualify this type of license. She was able to answer each question.

There are 153 signatures in petition/favor of this application.

Commissioner Camacho motions to grant the Class B, Beer, Wine and Liquor license to t/a Lisp Restaurant and Lounge, seconded by **Commissioner Norman**.

After Board vote, the motion carries.

 John Campanile, President/Board of Director, Michael Hartman, Audit Committee, for a Class B, Beer, Wine, and Liquor for the use of New Deal Café, Inc., t/a New Deal Café, 113 Centerway, Greenbelt, 20770. Represented by Bradley Farrar, Esquire.

Mr. Campanile is the President of the Board of Directors and is a Liquor Officer. Mr. Hartman is a Liquor officer as well.

Mr. Farrar states this establishment currently holds a license in the historic Greenbelt area, but they are adding a change in classification of the license to enhance the business. **Delegate Nicole Williams** testified in support of t/a New Deal Café.

the business with an alcoholic beverage license. She will be spending 40 hours a week on the premises and currently has 8 employees.

Chair Bridgwater-Simms asked the standard questions typically used to qualify this type of license. Ms. Thomas was able to answer each question.

Commissioner Camacho moves to grant the Class B, Beer, Wine and Liquor license for t/a The Pit Stop, seconded by **Commissioner Norman.**

After Board vote, the motion carries.

4. Hua Wang, President, Stephen King Lo, Treasurer, for a Class B, Beer, Wine, and Liquor for the use of Li Chun Food Corporation, **t/a Li Chun Café**, 7101 Baltimore Avenue, Suite 1C, College Park, 20740.

Licensees have no attorney, acknowledges their right to an attorney and agrees to move forward without an attorney.

Chief Clark gave a maps presentation.

Councilman Hew of College Park testified in favor of this application.

Ms. Wang opened her first business in 2015. She recently opened Li Chun Café to introduce new flavors, warm hospitality and delicious food. Many customers requested alcohol with their food, the license would fulfil the desires of the customers.

Mr. Lo expresses his desire to acquire an alcoholic beverage license.

Chair Bridgwater-Simms asked the standard questions typically used to qualify this type of license. Both Ms. Wang and Mr. Lo were able to answer each question.

Commissioner Camacho motions to grant the Class B, Beer, Wine and Liquor license to t/a Li Chun Café, seconded by **Commissioner Norman.**
