In the matter of **t/a House of Soul Restaurant and Bar**, located at 9430 Annapolis Road, Suite B, Lanham, 20706. See email dated November 17, 2025, from licensee Darnell Dinkins, regarding notification not to approve any agreements to remove his name from the License.  
The Board has noted this notification.

The Board acknowledged receipt of the DSCO application.

In the matter of **t/a Huncho House**, located at 6541 American Blvd, Hyattsville, 20781. Notification regarding the closure of the establishment due to a lease disagreement.

Commissioner Camacho moved to show-cause, which was approved by unanimous consent.

See letter dated December 2, 2025, regarding a request to temporarily close the establishment for entertainment only from December 2-29, 2025, due to a sewage issue, which will require renovations.
