Commissioner Camacho: At the Board of License Commissioners, we endeavor to be as efficient as possible in our virtual environment. Thank you for your patience. This is a public meeting subject to the Maryland Open Meetings Act so a truthful, transparent, open, and honest dialogue and record is required. As such, there are some formalities that will take place that may appear redundant but nonetheless are important and required to ensure compliance with the law.

PRELIMINARY MATTERS

1. Substitution of Corporate Officers application, t/a **Red Robin Gourmet Burgers & Brews**, Class B(BLX), Beer, Wine and Liquor, 15650 Excelsior Drive, Bowie, 20716, Jesse Griffith to serve as President/Treasurer, instead of Todd J. Wilson, President/Treasurer. Represented by **Linda Carter, Esquire**.
Ms. Carter requested a continuance to the next available hearing.
