In the matter of **t/a Best Fried Chicken, Crab & Seafood**, the Board reviewed an alleged Change in Mode of Operation violation.

Mr. Camacho moved to show cause for the establishment and approved by unanimous consent.

In the matter of **t/a Triangle Beer, Wine and Convenience**, the Board reviewed an alleged Alcohol Awareness violation.

Mr. Camacho moved for an offer and compromise with a fine of \$250 and to take an Alcohol Awareness Training within 90 days. Approved by unanimous consent.

In the matter of review of the background for Tara Williams to determine whether she meets the suitability requirements for an alcoholic beverage license. Ms. Williams is listed as a stockholder on the application for BuzzPoint Café, which is scheduled for a hearing on April 28, 2026.

The Commissioners voted by unanimous consent to have a conversation with Ms. Tara Williams on the April 28, 2026, hearing to determine whether she meets the suitability requirements for an alcoholic beverage license.

In the matter of **t/a Mix and Mingle**, located at 8923 Woodyard Road, Clinton, 20735. See email dated February 27, 2026, regarding a request to removed Shannon Jordan as a licensee and transfer her 34% membership interest to the following:

In the matter of **t/a Alegria Food Court**, located at 1535 University Blvd. E, Unit A1, Hyattsville, MD. See letter dated March 11, 2026, notifying the Board that the establishment has decided to close.

The Commissioners noted that the establishment has decided to close.

In the matter of **t/a Costa Del Sol Restaurant Bar and Grill**, located at 4819-21 Annapolis Road, Bladensburg, 20710. See letter dated March 27, 2026, regarding a request to approve an additional one hundred eighty (180) days to effectuate the license. The establishment is still experiencing delays due to outstanding construction and the certification of occupancy. The licensee expects to complete all remaining items by September 21, 2026. The Commissioners voted by unanimous consent to approve the request for an additional one hundred eighty (180) days to effectuate the license.

In the matter of **t/a Tropicana Grill & Food Market**, located at 3503-3505 Maryland Avenue, Cheverly, MD, 20785. See letter dated March 31, 2026, requesting that the Board review the assessed fine and \$500 late fee. The licensee did not receive any mailed notice regarding the violation and asks for consideration to resolve the matter by paying the original fine of \$250.

Mr. Camacho moved to rescind the \$500 late fee. Approved by the Commissioners voted by unanimous consent.
