See letter requesting permission for a temporary extension of the licensed premises into a designated section of the parking lot to host the Taste of Prince George's County – A Taste Testing Celebrating Local African American-Owned Spirits Brands on Saturday, July 18, 2026, from 2:00 p.m. to 6:00 p.m.

6. **Request to Amend Charges and provide an Offer and Compromise**

On May 13, 2026, the Board issued a Show Cause proceeding against Amigo's Mexican Grill alleging multiple violations of the Board's Rules and Regulations. Following additional discussions with representatives of the City of Laurel and the Laurel City Police Department, the Director has determined that the most appropriate charge is a single violation of Rule and Regulation #89, Compliance with Governmental Authority.

Accordingly, the Director of the Board of License Commissioners respectfully requests that the previously issued charges be amended to a single count alleging a violation of Rule and Regulation #89. Given this amended charge would the Board consider an Offer and Compromise or would the Board rather keep the Show Cause decision.

In support of this request, the Director notes that the licensee has no prior violations before the Board.
