## CHARGES:

Allegedly Mary Joines' cat is causing a public nuisance by virtue of running at large and causing unreasonable annoyance, disturbance, or discomfort to neighbors or others in close proximity to the premises where the animals are kept or harbored. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances' and Section 3-135 'Animals at Large Prohibited' of the Prince George's County Code.

CHARGES:
Allegedly on December 9, 2022, Mr Garry's Terrier Mix "Zaila" was running at large and entered onto the Collins property. Mr. Garry's animal then began to attack the victim dog belonging to the Collins family. The attack resulted in the death of the Collins family pet on scene. Mr. Collins was also bit by the attacking dog during the attack. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances’, Section 3-132 ‘Public Nuisance Conditions’, Section 3-135 ‘Animals at Large Prohibited’, Section 3-136 ‘Dangerous Animals', Section 3-142 'Irresponsible Owner', Section 3-182 'Potentially Dangerous Animal' and Section 3-186 'Vaccination of Ferrets, Dogs, and Cats' of the Prince George's County Code.

# No. 7-23 VA PRINCE GEORGE'S COUNTY, MD <br> v. <br> MONICA JONES 

## CHARGES:

Allegedly on December 13, 2022, Monica Jones' 7 American Bulldogs were running at large and attacked Mr. Cody's Yorkshire terrier being walked on leash. The incident resulted in the death of Mr. Cody's dog at the scene of the attack. This is a violation of Section 3-131 'Manner of Keeping Animals; Prohibition of Nuisances’, Section 3-132 ‘Public Nuisance Conditions’, Section 3-135 ‘Animals at Large Prohibited', Section 3-136 'Dangerous Animals', Section 3-142
'Irresponsible Owner', and Section 3-182 'Potentially Dangerous Animal' of the Prince George's County Code.

## GENERAL RULES

Cases shall be called in the order in which they appear on the docket. The Commission may consider cases out of the order presented on the written docket, at the discretion of the Chairperson, to promote efficiency and as an accommodation to the parties involved.

All attempts will be made to allot time fairly to opposing parties and witnesses. However, all persons testifying under oath shall speak only after receiving recognition and consent of the Chairperson.

Hearings are open to the public. Verbal and physical disruptions from the public are prohibited. Members of the public are required to comply with rules, directives, and orders of the Commission.
