 <u>15-23: 6202 Livingston Road — Douglas Roeser</u> Selling drug paraphernalia, numerous police service calls, loitering, trash & debris, loud music.

2. <u>16-23: 2308 Iverson Street — Douglas Roeser</u>

Trash & debris, illegal signage, illegal display of pennants, banners, and similar circus/carnival type attractions.

Trash & debris, operating without a U & O permit, unauthorized and illegal signage, illegal display of pennants, banners, and similar circus/carnival type attractions.

- <u>18-23: 7229 Landover Road Douglas Roeser</u> Trash and debris, unauthorized signage, wrecked, dismantled, or unlicensed vehicles stored, permitting issues
- <u>19-23</u>: <u>13906 Clemerra Way Douglas Roeser</u> Illegal parties without proper permitting, trash & debris, loud music, disruption of the neighborhood, serving food and alcohol.

Open storage, business equipment, unregistered/inoperable vehicles, trash & debris, operation without proper permits
