Michelle Lyons called the meeting to order at 1:19 PM.

TTFCC Meeting Minutes August 27, 2025

Michelle Lyons read Items 1-2 into the record noting there were no conditions or restrictions.

Michelle Lyons asked if there were any motions regarding Items 1-2. James Stepowany made a motion to recommend Item 1 and Item 2. Clarence Moseley seconded the motion, and it was unanimously approved.

Michelle Lyons advised the remaining items on the agenda were administrative approvals that did not require discussion.

Michelle Lyons moved the meeting into an executive session with the committee members.

The discussion item was a case from the July agenda:

Case #695-2025Colocation – Oxon Hill Middle SchoolCouncil 8AT&T9570 Fort Foote RdFort Washington

Michelle Lyons advised a vote was needed to be taken regarding a recommendation. There is an existing lease between PGCPS and the monopole owner. The applicant advised in correspondence to the committee that this lease was renewed in February, 2025 but the committee had not been forwarded a copy.

Mary Outlaw advised the contract was renewed at that time but did not have the details as to whether the monopole owner could approve new colocations over PGCPS objections.

James Crane advised the application was for a first-time colocation by AT&T on an existing monopole. The third-party review by CTC gave the proposal a positive recommendation. AT&T would be the fourth commercial carrier to colocate.

At the July 16, 2025, meeting the PGCPS committee member in attendance (Gary Cunningham) advised that the Prince George's County School policy was not to allow any new carriers on sites on school property. No vote was taken on the proposal and the carrier, its representatives, and the school representatives were advised to discuss the proposal further.

On August 15, 2025 meeting, the applicant forwarded notice that its position was the PGCPS lease with the monopole owner did not preclude a colocation. As this was a 6409 application, the FCC shotclock was in effect. The applicant would consider the application granted by September 14, 2025 if written notice justifying a rejection was not provided.

Niray Gori confirmed the case qualifies as a 6409 application.

Michelle Lyons advised that the responsibility of the committee in regard to the shotclock required a vote.

James Crane noted that the application could also be presented to the committee with a conditioned recommendation stating that the applicant obtain written approval from PGCPS at final permitting.

Clarence Moseley asked about potential legal ramifications of this case.

Michelle Lyons advised that if there was no vote, the committee would be liable for violations of the shotclock by not acting on an action brought before the committee. If the monopole owner has the lease authority that the applicant cited, it would be a legal issue between the monopole owner and PGCPS and that would not include the committee.

Lakisha Pingshaw stated she agreed with Michelle Lyons and the committee had done its due diligence by postponing the vote to hear from the PGCPS and offering PGCPS risk mitigation by conditioning the recommendation.

Nathaniel Tutt advised that since this case had met all requirements from an engineering standpoint, the practical step was to move the case forward so the applicant and PGCPS could have further conversation.

Michelle Lyons asked if there was a motion. James Stepowany made a motion to recommend the application. Clarence Moseley seconded the motion, and it was unanimously approved with the condition that the applicant provide written approval from Prince George's County Public Schools regarding the installation and its attachments at the time of final permitting.

The meeting was adjourned at 1:40 PM.
