Ms. Scott was seated for Dr. Pratt (delayed arrival). There were two guests: Lucian Jessel, University of Maryland student and Nia Hyndsmen, representative for Congressional candidate, Quincy Bareebe.

**MINUTES**

A motion was made by Ms. Deegan, seconded by Ms. Howell, and duly passed accepting the minutes for the November 10, 2025, regular meeting.

**ADMINISTRATOR'S REPORT**

Correspondence

- Update to correspondences from the Public Interest Legal Foundation requesting information based on the National Voter Registration Act of 1993. Mr. Horne spoke with the attorney representing the Public Interest Legal Foundation, and it was determined that the only information redacted would be the source of registration. Ms. Honesty-Bey provided the information requested.

Voter Registrations – The Maryland Voter Registration System is updated based on information received from the registrants, ERIC (Electronic Registration Information Center), MVA (Motor Vehicle Administration, NCOA (National Change of Address), and other reports. This report is available on the BOE website.

Maryland Association of Election Officials (MAEO) – Prince George’s County BOE hosted the November 18, 2025, MAEO meeting. The attendees were given a tour of the warehouse facility. It was a good meeting with many questions and a lot of information shared.

## **NEW BUSINESS** –

Polling Place Locations – Ms. Honesty-Bey noted that the BOE website includes a “Polling Place Change Notification Form” which can be completed to request email notification of proposed polling place changes. Notices must be sent to interested parties fourteen (14) days prior to the Board voting on the changes. The November 13, 2025, notification needs to be revised (change wording from Presidential Election to Gubernatorial Election). Ms. Honesty-Bey will schedule a virtual meeting to adopt the changes.

Ms. Honesty-Bey presented the following polling place items for review and approval:

- Election Day Polling Places  
A motion was made by Ms. Deegan, seconded by Dr. Pratt, and duly passed accepting the polling places from 2024 that did not change.
- Early Voting Sites (11 approved sites from 2024 and two additional sites – Baden ES and Trinity Assembly of God).  
A motion was made by Ms. Deegan, seconded by Ms. Lundy, and duly passed approving these locations.
- Drop Box Locations (same locations approved for 2024, plus Trinity Assembly of God).  
A motion was made by Ms. Deegan, seconded by Ms. Scott, and duly passed approving these locations.

Election Judges Training Manual – Election Judge training begins February 2026. SBE training for trainers is scheduled for January 2026. Ms. Honesty-Bey reported that BOE will not be printing manuals for each Election Judge. The manual will be available online, and copies will be printed for each precinct. Election Judge training is completed using training guides. BOE is looking at vendors that could develop training modules specific for Prince George’s County. This effort will involve a procurement process.

**LEGAL** – Mr. Whitely reported that Ms. Honesty-Bey would be deposed on December 2, 2025. It is expected that they will file a motion to exclude the BOE. Ms. Honesty-Bey noted that there were two specific questions she would be asked:

- The Gubernatorial Primary Election is scheduled for June 23, 2026. When do you need finalized maps?
- How do we administer an election?

Comments from the guests.

- Lucian Jessel noted that the University's students want to help share election information with students and provide updated information about students moving, etc. to update the voter rolls.
- Nia Hyndsman is looking for information about polling place locations and election results by precinct.

**NEXT MEETING** – The next regular meeting is scheduled for Monday, January 5, 2026, at 5:30 p.m., and it will be held in-person at the BOE Office.

A motion was made by Ms. Deegan, seconded by Dr. Pratt, and duly passed to close the meeting at 6:30 p.m.
