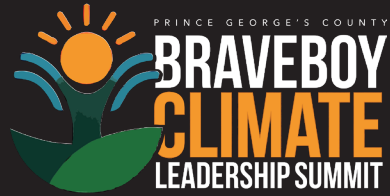

Pat Lawson Muse
Emcee

Pat Lawson Muse is an Emmy award-winning former news anchor with NBC4-TV in Washington, DC where she spent nearly 41 years before retiring in March of 2023.

Muse joined NBC4 in 1982 as an anchor and reporter. That year, Pat and Barbara Harrison became the first female television news anchor team in the country on News4 at Noon. Muse later anchored weekend editions of News4 at 6pm and 11pm and News4 at 4pm. For years she hosted NBC4's

community affairs programs including News4 Your Sunday, Reporter's Notebook and Viewpoint. For more than three decades she was the face and heart of NBC4's "Food 4 Families" campaign which has fed tens of thousands of families at Thanksgiving.

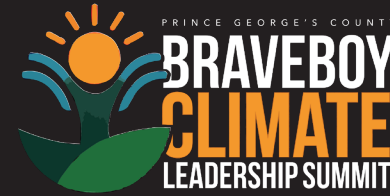
Muse's Emmy awards include the prestigious Board of Governors Award by the National Academy of Television Arts & Sciences, National Capital Chesapeake Bay Chapter. She's received multiple Emmys for news anchoring and multiple Emmy nominations for news reporting. In November of 2023, Muse received the 'Lifetime Achievement Award' from the Washington Association of Black Journalists.

Muse has been honored by the U.S. House of Representatives as Maryland Congressman Jamie Raskin's 'Hero of the Week' for her outstanding career in local television news and community service. She was also presented citations by Maryland Gov. Wes Moore, the Maryland State Senate, the Maryland House of Delegates and the Prince George's County State's Attorney.

Her work has been recognized by the American Association of University Women, the National Association of Black Journalists, the International TV and Film Festival of New York, the National Congress of Black Women, Inc. DC Chapter, and the Minority Business & Professionals Network.

Muse's broadcast journalism career began in 1977 in Washington, DC radio, including WTOP-AM, WHUR-FM, WOL-AM, National Public Radio, and the former Mutual Black Network. Her television news career began in 1980 at WBAL-TV in Baltimore.

Muse is a magna cum laude graduate of Howard University where she earned a degree in broadcast management and radio production. She's a native of Las Vegas, Nevada and lives in Prince George's County with her husband, Maryland State Senator C. Anthony Muse.

Dr. Aminta H. Breaux has served as the visionary 10th president of Bowie State University since July 2017, bringing more than 30 years of diverse higher education leadership experience to the position. As president, she is committed to ensuring that every student at Bowie State University develops an entrepreneurial mindset to achieve success in the rapidly changing workplace and communities. Dr. Breaux initiated a university-wide focus to infuse entrepreneurship education across the disciplines which led to the opening of an Entrepreneurship Living Learning Community in fall 2021. She

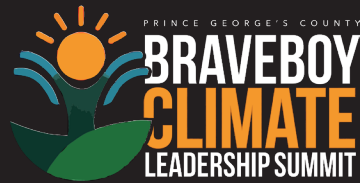
is dedicated to building on the legacy and rich history of Maryland's oldest historically Black university with a strategic focus on ensuring the long-term viability of the institution.



The Honorable Aisha N. Braveboy
Prince George's County Executive

Aisha N. Braveboy was elected County Executive of Prince George's County on June 3, 2025, during a special election and was sworn in as County Executive on June 19, 2025, after serving six years as Prince George's County State's Attorney. Remaining true to our commitment of service, In her last two days as State's Attorney, Ms. Braveboy remained focused on delivering justice for the people of Prince George's County. She was engaged in a two-week jury trial that resulted in a first-degree murder conviction. She also took immediate action on two of her key priorities as County Executive:

Prince George's County Public Schools (PGCPS) and public safety. Anticipating the removal of the PGCPS Superintendent, she acted quickly to unite stakeholders behind her choice of an Interim Superintendent. She also identified and rallied support for a new Police Chief, an internal candidate from the Prince George's County Police Department (PGPD) who is community-focused and deeply familiar with the County. County Executive Braveboy is a lifelong public servant, uniquely distinguished in County history for having served in all three branches of government: Executive, Legislative, and Judicial. She was twice elected State's Attorney for Prince George's County, first in 2018 and again in 2022, representing over one million residents. In that role, she managed a \$24 million budget and a staff of over 200. As the County's top law enforcement officer, she secured over a 90% conviction rate in homicide cases and implemented programs to reduce recidivism, support survivors of domestic violence, address hate crimes, and combat gun violence. As County Executive, she will continue to advance a comprehensive public safety strategy to build stronger, safer communities.

The Honorable Edward P. Burroughs III
Council Chair, District 8

Edward Burroughs (D) - District 8 was sworn into office on Tuesday, February 15, 2022, following a Special Election to fill the District 8 Council seat left vacant in November 2021. District 8 constituent areas include Andrews Air Force Base, Camp Springs, Forest Heights, Fort Washington, Oxon Hill, and Temple Hills. A lifelong resident of Prince George's County, Burroughs is a graduate of Crossland High School. In 2008, he was elected by his peers to serve as the student member on the Board of Education, representing the interests of over 130,000 Prince George's County Public School students.

Following two one-year terms as a student member, Burroughs became the youngest elected official in Maryland when he was elected to represent District 8 on the Board of Education. He held the position until his resignation in 2021.



The Honorable Ingrid S. Watson
Council Member, District 4

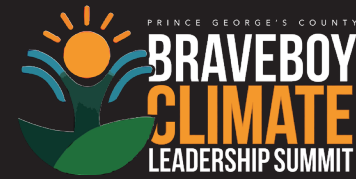
Ingrid Scott Watson (formerly Harrison) was elected in the November 2022 General Election to her first term on the Prince George's County Council and represents Councilmanic District 4. Council Member Watson's longstanding history of community service in the county spans 27 years. In November 2018, she was elected to the Prince George's County Democratic Central Committee, Legislative District 23B. In November 2019, she was elected to an At-Large seat on the Bowie City Council. In this capacity, she served as Council Liaison to the Public Safety and Diversity committees; the Bowie Racetrack Executive Board; and spearheaded development of the Youth Advisory Committee.



The Honorable Wala Blegay
Council Member, District 6

Wala Blegay was elected to serve her first four-year term on the Prince George's County Council in the November 2022 General Election and represents Councilmanic District 6. She was elected as Vice Chair by her peers during her first term on the Council. During her first term, she spearheaded an aggressive people-driven agenda authoring legislation to encourage quality development in the county, limiting tobacco stores and marijuana shops in residential communities, incentivizing healthy restaurants, providing tax credits for public safety employees, creating a task force to

address emergency room wait times, requiring security cameras in high-capacity apartment buildings, rent stabilization and more.

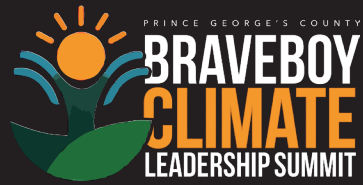
of Valencia College, and her data-driven results demonstrate her ability to achieve lasting, remarkable outcomes through effective leadership and partnership building.

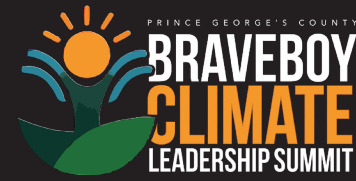

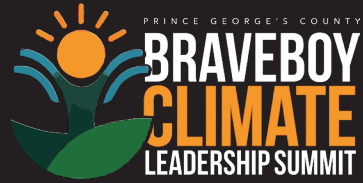

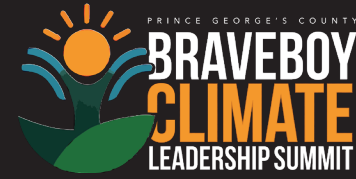
Kishia L. Powell

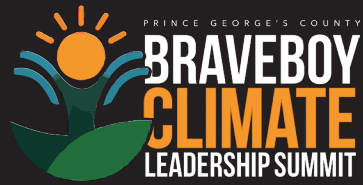
The Honorable Serena C. Mclwain

Mayor, City of District Heights

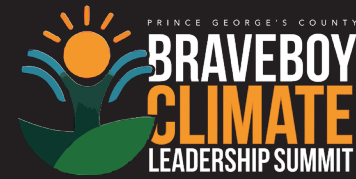

& Transportation*

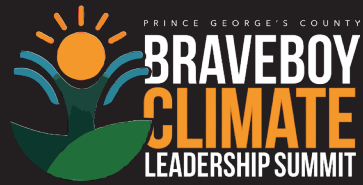

through January 2022, Mary's efforts directly supported the Chair of the Prince George's County Climate Action Commission, DoE's Associate Director, Dawn Hawkins-Nixon, bringing together the ideas of a diverse group of Commissioners, consultants, colleagues, and county residents to develop and draft the Prince George's Climate Action Plan(CAP) to County Council which County Council ultimately adopted in July of 2022. Beyond her climate action work, her expertise encompasses environmental and sustainable site design, piloting innovative green infrastructure stormwater management solutions, and ecosystem restoration projects, including the County's first channel restoration project (Calverton Channel) and the first RSC (William Wirt Regenerative Stormwater Conveyance). Within DoE's Sustainability Division, Mary's team manages the Prince George's County Urban Tree Program, now annually on track to plant thousands of street trees within the public spaces of our municipalities, HOAs, and churches; climate-resilient stormwater management modeling projects, the Prince George's County Master Gardener Program; and the USDA Advancing Markets for Producer Grant for County farmers. 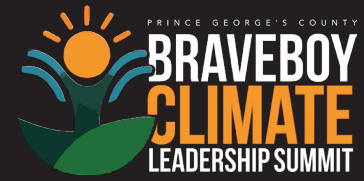

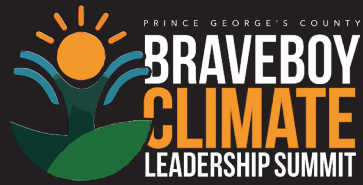
modernizing public-sector fleet and stormwater systems to enhance efficiency, sustainability, and climate resilience.

Council Member, District 2

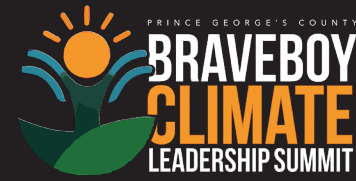

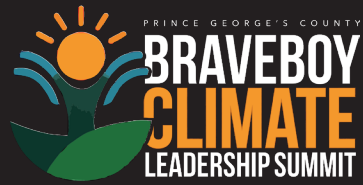
Gabriela Rivera

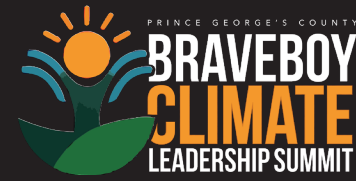

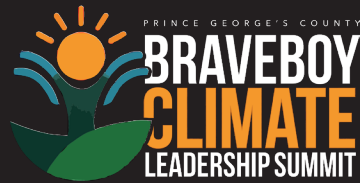

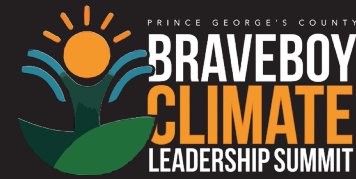
John Deadwyler

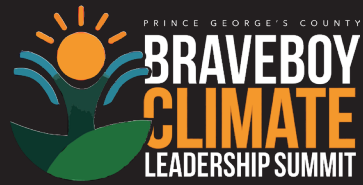
Kelsey Brooks

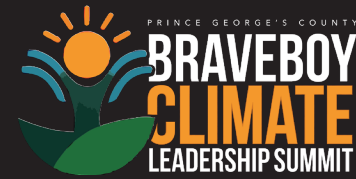
Pamela Boozer-Strother

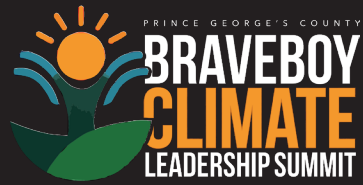
