CHARGES:

Allegedly, on January 19, 2026, Mr. Sei was delivering a package and was bitten by Mr. Enriquez' small, white, dog. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of Dogs, Cats, and ferrets', Section 3-145 "License of Dogs, Cats, and ferrets", of the Prince George's County Code.

CHARGES:

Allegedly, Ms. Wormley's Husky type dog had attacked Ms. Simmons in a common area in front of her residence on April 6, 2026. She states that during the attack, Ms. Wormley stood by and expressed that she could not control her dog. Ms. Simmons points out that the attacking dog has a history of running at large and aggressively approaching residents. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; Section 3-186 'Vaccination of Dogs, Cats, and ferrets'; and Section 3-145 "License of Dogs, Cats, and ferrets", of the Prince George's County Code.

CHARGES:

Allegedly, Mr. Gonzalez's two medium-sized, Shiba Inus has attacked Ms. Rowan's pet on multiple occasions; most recently on March 6, 2026. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of Dogs, Cats, and ferrets'. Section 3-145 "License of Dogs, Cats, and ferrets", of the Prince George's County Code.

CHARGES:

The Prince George's County Animal Services Division, PGASD, is requesting an Animal Control Commission hearing regarding the above listed animal(s) impounded from the address. Allegedly, on April 11, 2026, PGASD found the listed animals above outdoors in wire dog crates with no access to water. Two out of three of the dogs appeared to have thick matting of fur all over the body. Due to the matting, PGASD was unable to view the body condition of the dogs as well as their genders. All three dogs presented with smell of feces and urine. Dogs were removed from the address for their health and safety. This is in violation of Section 3-131 'Manner of Keeping Animals' (a) 'Proper Food'; (b) 'Proper Water'; (c) 'Proper Shelter'; (d) 'Proper Space'; (e) 'Proper Care'; (f) 'Proper grooming'; (g) 'Proper Cleaning'; Section 3-133 'Sanitary Conditions for care and maintenance of animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'License required for dogs, cats, and ferrets'; Section 3-180 'Animal Cruelty and Neglect Prohibited'; 'Section 3- 186 'Rabies for dogs, cats, and ferrets;

CHARGES:

Allegedly, Ms. Florez large, brown, German Shepherd type dog had bitten Ms. Perry's younger son at the park on March 25, 2026. Ms. Perry states that the attacking dog has a history of running at large and has charged at her older son on November of 2025. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals';

Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’; and Section 3-145
“License of Dogs, Cats, and ferrets’, of the Prince George’s County Code.
