Allegedly, the Reed's Cane Corso has been repeatedly jumping over their fence and trespassing into Ms. Singleton's property. On May 29, 2026, the Reed's Cane Corso bit Singleton's dog in the back. This is in violation of Section 3-131, 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat licenses'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of ferrets, dogs, and cats' of the Prince George's County Code.
