CHARGES:

Allegedly, Mr. Harris and Ms. Menjivar's three large, dark gray Cane Corso's were left in a vehicle unattended as Mrs. Mundaca and her leashed dog, 'Fluffy' were exiting the Walmart at 3300 Crain Highway in Bowie, MD. The dogs managed to roll down the window and viciously attack Mrs. Mundaca and 'Fluffy'. When Mr. Mundaca noticed Mrs. Mundaca and 'Fluffy' getting attacked, he quickly ran to their aid to intervene in the attack, resulting in the dogs attacking him. Both Mr. and Mrs. Mundaca were left severely injured and 'Fluffy' was deceased from the attack. This is in violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animal'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.

CHARGES:

The Prince George's County Animal Services Division is requesting an Animal Control Commission hearing regarding the above listed animal(s) impounded from 4400 Stamp Rd Temple Hills MD 20748. Allegedly on February 12, 2025, Prince Georges County Animal Services received a call from Police Communications for a small brown poodle inside of a cage in the backseat of a Black Chrysler 300 4 door car with South Carolina tag #WVX726 parked in front of the address. Says the animal has been in the car crying since last night. Upon investigation the responding ACO found one small brown poodle inside of a crate in the rear seat of the car. Fire department unlocked the vehicle and gave access to ACO. Officer impounded the animal for its health and safety.

CHARGES:

Ms. Hendrix is requesting a Hearing for the return of her of her dog, which appears to be a mixed Staffordshire Terrier / French Bulldog named 'Rah Rah' that was impounded on April 22, 2025, in relation to a dog beating investigation. Video evidence was provided to our agency to support this claim. This is in violation of Section 131 'Manner of keeping animals-Proper Care', Section 3-142 'Irresponsible Pet Owner', Section 3-180 'Cruelty to animals', Section 3-186 'Rabies vaccination required for dogs, cats, and ferrets', of the Prince George's County Code.
