**CHARGES:**

Allegedly, Mr. Saylor's dog was running at large and bit Ms. Hill's six-month-old dog. This is in violation of the Commission for Animal Control Section 3-131 'Manner of keeping animals; prohibition of nuisances'; Section 3-132 'Public nuisance conditions and animals; procedures; appeals; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous animals;' Section 3-142 'Irresponsible Pet Owner'; Section 3-145 "Ferret, dog, and cat licenses"; Section 3-182 "Potentially dangerous animal"; and Section 3-186 "Vaccination of dogs, cats, and ferrets" of the Prince George's County Code.

Allegedly, Mr. Poubrio's male, Rhodesian Ridgeback has roamed off-leash on May 8, 2025, and killed four of Hutchinson's chickens. This is in violation of the Commission for Animal Control Section 3-131 'Manner of keeping animals; prohibition of nuisances'; Section 3-132 'Public nuisance conditions and animals; procedures; appeals; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous animals;' Section 3-142 'Irresponsible Pet Owner'; Section 3-145 "Ferret, dog, and cat licenses"; Section 3-182 "Potentially dangerous animal"; and Section 3-186 "Vaccination of dogs, cats, and ferrets" of the Prince George's County Code.

Allegedly, Ms. Fennell continuously allows her small, white, chihuahua to be off leash. Her dog has bitten Ms. Manan twice. **CHARGES:**

Allegedly, Mr. Harris and Ms. Menjivar's three large, dark gray Cane Corso's were left in a vehicle unattended as Mrs. Mundaca and her leashed dog, 'Fluffy' were exiting the Walmart at 3300 Crain Highway in Bowie, MD. The dogs managed to roll down the window and viciously attack Mrs. Mundaca and 'Fluffy'. When Mr. Mundaca noticed Mrs. Mundaca and 'Fluffy' getting attacked, he quickly ran to their aid to intervene in the attack, resulting in the dogs attacking him. Both Mr. and Mrs. Mundaca were left severely injured and 'Fluffy' was deceased from the attack. This is in violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animal'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.

Allegedly, Mr. Bard's two dogs were outside, unleashed when they attacked Mr. Priester's dog on June 3, 2025. Mr. Priester's dog sustained severe injuries because of the attack and needed emergency veterinary care. This is in violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animal'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.
