CHARGES:

The Prince George's County Animal Services Division is requesting a Dangerous dog hearing for the above listed animal(s). Allegedly on September 23, 2025, the above listed dog escaped from the front door of the owner's home and attacked Ms. Patterson unprovoked, as she was entering her own home next door. Ms. Patterson sustained multiple bite injuries to her left leg that required sutures and extended medical care. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of Dogs, Cats, and ferrets'.

Mr. Priester’s dog sustained severe injuries because of the attack and needed emergency veterinary care. This is in violation of Section 3-131 ‘Manner of Keeping; Prohibition of Nuisances’; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animal’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-145 ‘Ferret, dog, and cat license’; Section 3-182 ‘Potentially Dangerous Animals’; Section 3-186 ‘Vaccination of dogs, cats, and ferrets’ of the Prince George's County Code.

CHARGES:

Allegedly, Ms. Willis’ two, mixed breed dogs had attacked her dog on August 2, 2025, and most recently, August 4, 2025. This is in violation of Section 3-131, “Manner of Keeping Animals”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 “Running at large prohibited”; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-145 ‘Ferret, dog, and cat licenses’; and Section 3-182 ‘Potentially Dangerous Animals’ of the Prince George's County Code.

This is in violation of Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animal’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-145 ‘Ferret, dog, and cat license’; Section 3-182 ‘Potentially Dangerous Animals’; Section 3-185.01 ‘Pit Bull Terriers’ Section 3-186 ‘Vaccination of dogs, cats, and ferrets’ of the Prince George's County Code.
