### **CHARGES:**

The Prince George's County Animal Services Division is requesting a Dangerous dog hearing for the above listed animal(s). Allegedly on May 2, 2025, the above listed dog jumped the fence of the rear yard of its home where it was being maintained unsupervised and attacked Mrs. Toni Cox's dog "Nation" a Yorkshire terrier while Mrs. Cox was walking her dog on leash in the 300 Block of Possum Ct. Mrs. Cox took her dog to be seen by a veterinarian for the injuries sustained which resulted in the dog having to be euthanized due to the severity of injury. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-

182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of Dogs, cats, and ferrets'.

## **CHARGES:**

Allegedly, on May 15, 2025, the respondents two huskies were running at large when they attacked and killed the complainants three rabbits located on the premises of 8517 58<sup>th</sup> Avenue, Berwyn Heights, MD. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses." And Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.

### No. 133-25 VA JAMES GRANT MCKENZIE

v.

### **CHARGES:**

Allegedly, On July 9, 2025, at approximately 8:45 AM, Mr. McKenzie was walking his leashed dog, "Whiskey," on Bonnie Meadow Lane when the respondent's unleashed dog was encountered. Although the respondent initially leashed his dog after it showed aggressive behavior, upon Mr. McKenzie's return, the neighbor's dog lunged across the street and attacked "Whiskey," biting its neck. The attack continued and the respondent's dog chased "Whiskey" back onto Mr. McKenzie's property at 713 Bonnie Meadow Lane, where the dog then bit Mr. McKenzie's lower right calf multiple times, causing puncture wounds and severe bruising that required emergency medical treatment. The respondent retrieved the animal but returned minutes later while Mr. McKenzie was on the phone with 911 seeking emergency assistance. This is in violation of the Commission for Animal Control Section 3-131 'Manner of Keeping Animals'; Section 3-132 'Public nuisance conditions and animals; procedures; appeals; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous animals;' Section 3-142 'Irresponsible Pet Owner'; Section 3-145 "Ferret, dog, and cat licenses'; Section 3-182 "Potentially dangerous animal'; Section 3-185.01 "Pit Bull Terriers" and Section 3-186 "Vaccination of dogs, cats, and ferrets" of the Prince George's County Code.

### No. 130-25 VA DANA SHULER

# **CHARGES:**

Allegedly, on May 18, 2025, in Upper Marlboro, MD, Mr. Williams' two dogs, unleashed and unsupervised, attacked Ms. Shuler's leashed dog while walking on Birdie Lane. The attack was unprovoked. This isn't an isolated event. On February 16, 2024, Mr. Williams' unsecured dogs, originating from his unfenced property, also attacked Mr. Shuler and his dog. Mr. Shuler managed to fight them off during that prior incident. This is in violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animal'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat license'; Section 3-182 'Potentially Dangerous Animals'; Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.
