## **CHARGES:**

Allegedly Ms. Testerman's large, white, dog is causing a public nuisance by virtue of excessive barking. This is causing unreasonable annoyance, disturbance, or discomfort to neighbors or others near the premises where the animal is kept or harbored. This is a violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-134 'Excessive noise by an animal prohibited'; Section 3-142 'Irresponsible Pet Owner' of the Prince George's County Code.

## **CHARGES:**

Allegedly Mr. Cooper's three black and brown dogs are causing a public nuisance by virtue of excessive barking. Mr. Holman states that Mr. Cooper leaves his dogs outside, regardless of the climate. This is causing unreasonable annoyance, disturbance, or discomfort to neighbors or others near the premises where the animal is kept or harbored. This is a violation of Section 3-131 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-134 'Excessive noise by an animal prohibited'; Section 3-142 'Irresponsible Pet Owner' and Section 3-180 'Animal Cruelty and Neglect; prohibited' of the Prince George's County Code.

### No. 79-25 ERLY MERALI PEREZ FERINAN

v. JAQUELINE MANCADA

#### **CHARGES:**

Allegedly, Ms. Mancada's white and brown American Bulldog has been continually running at large and has killed Ferinan's animals. The most recent incident occurred on March 15, 2025, when Ms. Mancada's dog was running at large and killed one of Ms. Ferinan's chickens. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses." And Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.

## No. 80-25 PRINCE GEORGE'S COUNTY, MD

v. TYCHE FIELDS

#### **CHARGES:**

Allegedly on March 8, 2025, Mr. TyChe Fields was witnessed physically abusing his dog "Nyla" in the backyard of the address while the dog was tied to a 3-4 ft leash that prevented her from escaping. Upon initial investigation at the home the dog was found inside the home inside of a dark closet in a dog crate. After reviewing the video and conducting an investigation at the address the animal was removed for its health and safety. This is in violation of Section 3-131 (a) (3) 'Manner of Keeping; Proper Shelter; Section 131 (a) (4) 'Manner of Keeping; Proper Space'; (a)(6) 'Manner of Keeping; Proper care'; Section 3-131 (a) (9) 'Manner of Keeping; Proper Light'; Section 3-131 (a) (11) 'Manner of Keeping; Proper Air'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, Dog, and Cat licenses'; Section 3-180 'Cruelty and Neglect'; and Section 3-181 'Unlawful Restraint' of the Prince George's County Code.

#### No. 81-25 VA CITY OF COLLEGE PARK

v. TANYA SHOUCAIR

## **CHARGES:**

The City of College Park Animal Control is requesting a Dangerous Dog Hearing due to the dog listed above running at large and attacking dog "Rocky" a 7-year-old golden lab mix, causing severe injury, and injury to the hands Andy Ramirez on January 27th, 2025. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182

"Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses." of the Prince George's County Code.

This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-135 "Animals at Large Prohibited"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses." And Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.
