This is in violation of Section 3-131, “Manner of Keeping Animals”; Section 3-135 Section 3-142 “Irresponsible Pet Owner”; Section 3-136 “Dangerous Animals”; Section 3-182 “Potentially Dangerous Animal”; and Section 3-145 “Ferret, dog, and cat licenses.”

**CHARGES:**

The Prince George’s County Animal Services Division is requesting a Dangerous dog hearing for the above listed animal(s). Allegedly on August 7, 2025, Mr. Rayford brought his dog in to the Spay Spot as a citizen to have his dog neutered. Mr. Rayford warned the spay spot staff that the dog “nips”. When preparing the dog for neuter surgery the dog lunged and bit one of the vet techs in the hand causing injury to the hand and wrist and would not let go. This is in violation of Section 3-132 ‘Public Nuisance Conditions’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; and Section 3-182 ‘Potentially Dangerous Animals’.

**CHARGES:**

Allegedly, on July 9, 2025, Mr. Cohen’s unleashed, large, Pit Bull mixed dog approached and attacked Ms. Datham’s dog. This is in violation of Section 3-135 “Animals at Large Prohibited”; Section 3-142 “Irresponsible Pet Owner”; Section 3-136 “Dangerous Animals”; Section 3-182 “Potentially Dangerous Animal”; and Section 3-145 “Ferret, dog, and cat licenses.” And Section 3-186 ‘Vaccination of

dogs, cats, and ferrets' of the Prince George's County Code. This is in violation of Section 3-131, "Manner of Keeping Animals"; Section 3-142 "Irresponsible Pet Owner"; Section 3-136 "Dangerous Animals"; Section 3-182 "Potentially Dangerous Animal"; and Section 3-145 "Ferret, dog, and cat licenses." And Section 3-186 'Vaccination of dogs, cats, and ferrets' of the Prince George's County Code.
