This is in violation of Section 3-131 'Manner of Keeping Animals', Section 3-132 'Public nuisance conditions and animals; procedures; appeals, Section 3-134 'Excessive noise by an animal prohibited', and Section 3-142 'Irresponsible Owner', of the Prince George's County Code.
