CHARGES:

Allegedly, on January 19, 2026, Mr. Sei was delivering a package and was bitten by Mr. Enriquez’ small, white, dog. This is in violation of Section 3-131 “Manner of Keeping; Prohibition of Nuisances”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’, Section 3-145 “License of Dogs, Cats, and ferrets”, of the Prince George’s County Code.

CHARGES:

Allegedly, on February 23, 2026, Mr. Snoody was walking his dog, off-leash, when his dog trespassed into Mr. Avent and Ms. Fuller’s property and bit their dog. This is in violation of Section 3-131 “Manner of Keeping; Prohibition of Nuisances”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’. Section 3-145 “License of Dogs, Cats, and ferrets”, of the Prince George’s County Code.

CHARGES:

Allegedly, Ms. Robinson’s dog is frequently off-leash and has charged after residents and other animals. On December 9, 2025, her medium-sized, brown dog attacked Ms. Hayes’ dog near 5200 Lynns Retreat. This is in violation of Section 3-131 “Manner of Keeping; Prohibition of Nuisances”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’. Section 3-145 “License of Dogs, Cats, and ferrets”, of the Prince George’s County Code.

CHARGES:

Allegedly, Mr. Davies and Ms. Conner’s two American Pitbull Terriers have been running loose and have a history of being vicious. On March 9, 2026, Mr. Robertson and his dog were attacked by the two American Pit Bull Terriers. Both Mr. Robertson and the victim dog had to receive medical attention for the wounds incurred during the attack. This is in violation of Section 3-131 “Manner of Keeping; Prohibition of Nuisances”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’. Section 3-145 “License of Dogs, Cats, and ferrets”, of the Prince George’s County Code.

CHARGES:

Allegedly, Ms. Butler’s dog has been causing a public nuisance by virtue of excessively barking. This is in violation of Section 3-131 “Manner of Keeping; Prohibition of Nuisances”; Section 3-132 ‘Public Nuisance Conditions’; Section 3-134 ‘Excessive noise by an animal prohibited’; and Section 3-142 ‘Irresponsible Pet Owner’, of the Prince George’s County Code.
