RIOS GREGORIO PUMARINO

CHARGES:

The Prince George's County Animal Services Division is requesting a Dangerous dog hearing for the above listed animal. Allegedly, on November 1, 2025, Mr. Pumarino's dog "Rocky" was observed running at large by 3 ACOs and could not be securely contained. A housemate of Mr. Pumarino was finally able to catch the dog and ACOs then took custody of 'Rocky', for a pending ACC case. Prior to this incident Animal Services has responded to the address 7 additional times in 2025 referencing to complaints of this animal running at large, chasing feral cats potentially injuring them, and causing fear among citizens walking in the area. This is in violation of Section 3-131 (c) 'Manner of Keeping; Prohibition of Nuisances'; Section 3-132 'Public Nuisance Conditions'; Section 3-135 'Animals at large prohibited'; Section 3-136 'Dangerous Animals'; Section 3-142 'Irresponsible Pet Owner'; Section 3-145 'Ferret, dog, and cat licenses'; Section 3-182 'Potentially Dangerous Animals'; and Section 3-186 'Vaccination of dogs, cats, and ferrets'.

CHARGES:

Allegedly on October 25, 2025, the above listed dog while running at large attacked Ms. Janai Allen's dog "Chloe" an 8-year-old Yorkshire Terrier Mix as she was walking her dog on leash. The attack resulted in the death of Ms. Allens dog on scene. Prince George's County Sheriff's Officer stayed on scene until an Animal Control Officer arrived. This is in violation of Section 3-131 "Manner of Keeping; Prohibition of Nuisances"; Section 3-132 'Public Nuisance Conditions';

Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’.

Mr. Herbert is requesting the return of his female, Pit Bull Terrier mixed dog named ‘Smoke’.

Allegedly, Mr. Drier’s dog has been roaming the neighborhood, while unleashed. Ms. Lewis states that in September of 2025, Mr. Drier’s dog was running at large and attacked Ms. Lewis’ dog, ‘Zues’. This is in violation of Section 3-131 ‘Manner of Keeping; Prohibition of Nuisances’; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’.

CHARGES:

Allegedly, Mr Reyes’ four Siberian Huskies, one German Shepherd, and two smaller breed dogs have run into Ms. Hayes property and have chased her. They have also chased her horses, antagonized her dogs, and have killed her chickens. This has been an ongoing issue, the most recent event took place on November 4, 2025. This is in violation of Section 3-131 ‘Manner of Keeping; Prohibition of Nuisances’; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large prohibited’; Section 3-136 ‘Dangerous Animals’; Section 3-142 ‘Irresponsible Pet Owner’; Section 3-182 ‘Potentially Dangerous Animals’; and Section 3-186 ‘Vaccination of Dogs, Cats, and ferrets’.

CHARGES:

Allegedly, on November 16, 2025, Mr. Jones’ Pitbull was being walked off-leash when the Pitbull suddenly charged and attacked Mr. Lopez-Arias’ dog. This is in violation of Section 3-131 ‘Manner of Keeping; Prohibition of Nuisances’; Section 3-132 ‘Public Nuisance Conditions’; Section 3-135 ‘Animals at large

This is in violation of the Commission for Animal Control Case No. 118-24 VA. 3-131 "Manner of Keeping Animals: prohibition of nuisances"; 3-134 "Excessive Noise Prohibited"; 3-142 "Irresponsible Owners"; 3-145 "Dog, Cat, and Ferret License"; and Section 3-185 "Vaccination of dogs, cats, and ferrets."
