The Prince George's County Animal Services Division is requesting a non-compliance hearing for the above referenced property/animal owner, Dianna Gonzalez. Mrs. Gonzalez was brought before the Commission for Animal Control on September 25, 2024, for a Vicious Dog Hearing. Mrs. Gonzalez has failed to comply with the vicious dog restrictions as ASD has received 6 more complaints for animals at large from the residence in addition to failing to provide proof of vaccination, microchipping, and county license.
